## THE MINISTER OF TERRITORIAL ADMINISTRATION,

Mindful of the Constitution;

Mindful of Law No. 2015/012 of 16<sup>th</sup> July 2015 to lay down regulations governing entertainment games, money games and games of chance;

Mindful of Decree N°. 2011/408 of 09 December 2011 to organize the Government, as amended and supplemented by Decree No 2018/191 of 02 March 2018 to reorganize the Government;

Mindful of Decree No. 2018/191 of 02 March 2018 to reshuffle the Government;

Mindful of Decree No. 2019/030 of 23 January 2019 to organize the Ministry of Territorial Administration;

Mindful of Decree n°2019/2300/PM of 18 July 2019, to specify modalities for the application of Law n°2015/012 of 16 July 2015, to lay down regulations governing entertainment games, money games and games of chance;

Mindful of Considering the relevant file,

## **HEREBY ORDERS AS FOLLOWS:**

Article 1: (1) With effect from the date of signature of this order, LOYAL COUNTRY SAS, P.O. Box: 25 233 Yaounde, is authorised to organize online games throughout the national territory for a period of five (05) years renewable under trade name "MELBET".

(2) The holder of this authorization shall pay a licence fee whose amount and terms of payment shall be defined by a regulatory text.

(3) The amount referred to in paragraph 2 above shall be paid as soon as the text defining the license fee will be published.

(4) Failure to pay amount shall lead to the withdrawal of this authorization.

Article 2: The company cited in article 1 shall be represented by Mr BIWONO Joseph, its President.

<u>Article 3</u>: 1) **LOYAL COUNTRY SAS** shall be subject to the payment of taxes and duties provided for by the regulations in force, throughout the period set forth in article 1 above.

(2) This authorisation shall not be transferable to a third party. Any such transfer shall nullify the authorisation.

(3) This authorization shall be evaluated, every two (02) years, at the request of the Ministry in charge of gaming, to ensure its proper execution.

(4) LOYAL COUNTRY SAS undertakes never to lodge a complaint against the State of Cameroon or Ministry in charge of games.

Article 4: The Secretary of State for Defence in charge of the National Gendarmeric, the Delegate General for National Security, Governors, Seniors Divisional Officers and Divisional Officers shall, each within their sphere of competence, ensure the application of this order which shall bez registered and communicated wherever necessary./-
